### Overview

#### Family

Kate has substantial experience across a range of family law matters.

Kate has a strong public law practice, acting for parents, local authorities and guardians. She has represented parents facing allegations of non-accidental injury and sexual abuse and has experience of challenging expert medical evidence. She is able to provide appropriate advice and representation depending on the needs of the client, regularly representing parents with significant mental health needs and cognitive limitations. Kate has also been involved in a number of cases in which the court has taken a 'family drug and alcohol court' approach despite this not yet being formally implemented in the local area.

In private law cases, Kate acts in both Children Act disputes and domestic violence injunction matters. Kate has experience of cases involving both removal from the jurisdiction and internal relocation, as well as implacable hostility to contact.

Kate also regularly acts in financial remedy proceedings, representing clients at FDR and final hearing stage, as well as advising on the resolution of proceedings.

#### Civil

Kate has a strong personal injury practice including road traffic accidents (including low velocity impact cases and credit hire litigation), occupier's liability, and employer's liability cases. She provides written advice and pleadings as well as representation at court.

Building on her strengths as an ancillary relief practitioner, Kate is also available for TOLATA claims.
